Commissioner Todd questioned cost, and does not want to supplement the budget. McKeown mention this project may be part of the Capital Improvement Plan in the future. Bill Pearson suggested city do an annexation study with residents of Boulder Canyon for input. After discussion, Martinisko moved, Johnson seconded to advertise for Request for Qualifications to develop a plan to extend water and sewer infrastructure Ease of Deadwood into Boulder Canyon for the City of Deadwood with submittals due on December 3, 2019 at 2:00 p.m. with final selection presented on December 16 at City Commission meeting. Roll Call: Aye-All. Motion carried.

Agreement

Historic Preservation Officer Kuchenbecker explained ownership of artifacts. Commissioner Martinisko questioned the artifacts with a value of more than \$25,000.00 shall remain the property of Developer with City retaining first right of refusal. Attorney Riggins asked for continuation of agreement to allow for clarification with Developer. After discussion concerning cataloging, Martinisko moved, Struble seconded to continue Programmatic Agreement with Deadwood Hotels for artifacts found during TIF 11 project for archaeology investigation. Roll Call: Aye-All. Motion carried.

Nelson Jr. stated this is the next step in Firewise, Community Wide Assessment. Todd moved, Struble seconded to enter into contract with Black Hills Land Analysis LLC to develop a Community Assessment for Wildland Fire Mitigation planning in an amount not to exceed \$22,800.00. To be paid from additional BLM grant, consent item 6M. Roll Call: Aye-All. Motion carried.

Change Order

Kuchenbecker stated this changer order will provide service tie-in for sewer and water to both 334 and 336 Williams, add vapor barrier, water line casing pipe, and rigid insulation. Johnson moved, Struble seconded to approve Change Order #2 for 336 Williams Street retaining wall project in the amount of \$7,874.89, bringing total contract to \$115,929.83. Roll Call: Aye-All. Motion carried.

Easement

Ruth Jr recused himself, but will continue to conduct meeting. Commissioner Martinisko questioned the paragraph dealing with "Grantee shall not place snow or ice from the adjacent property onto the subject property involved in this easement." Attorney Riggins stated he will amend the easement. Kuchenbecker explained the deck would sit on top of the retaining wall, and maintains eighteen feet of opening to access the historic foundation of the theater. Commissioner Todd questioned if the retaining wall would be able to handle the deck. Martinisko moved, Johnson seconded to allow Mayor to sign amended Permanent Access Easement with Super G Investment Corporation for construction of covered patio adjacent to Outlaw Square.
