Struble moved, Johnson seconded to Act as Board of Adjustment and approve Findings of Fact and Conclusion - Conditional Use Permit - Bed and Breakfast - Deanna and Thomas Smith at 29 Van Buren St. (The Southerly 57 feet of Lots 21, 22, 23 and 24, Block 50 Original Townsite, City of Deadwood Lawrence County, South Dakota.) Recommend Approval by Planning and Zoning Commission on May 18, 2022.

Struble moved, Todd seconded to allow Fire Dept. to purchase four (4) Motorola AXP4000 and six (6) Motorola SL-300 radio/pagers from Western Communications in an amount not to exceed \$15,106.00. (To be paid from Fire Dept. Equipment budget.) Roll Call: Aye-All. Motion carried.

Public Works Director Nelson Jr. spoke about the contract. Martinisko moved, Struble seconded to accept quote and enter into contract with Tree Wise Men LLC for phase 6 of clean up to Whitewood Creek (Highway 385 to 320 Cliff Street) in the amount of \$29,700.00. First Reading

Russell spoke about the ordinance. He stated there are possible discrepancies with short-term rentals in different zoning districts. Mayor Ruth Jr. this is a process that started with a conditional use permit hearing. City recognized then that as a commission and community, we had to decide what type of densities each neighborhood would be ok with and what would be appropriate. Martinisko moved, Johnson seconded to approve first reading of Ordinance #1355, Temporary Moratorium for additional short-term rentals in the following zoning districts: Residential (R1), Residential Multi-Family (R2), Planned Unit Development (P.U.D.), Public Use and Park Forest. Pat Dringman, Block Club Representative of Stage Run, understands the zoning issue, requested a block club meeting to talk about short-term rentals. Mayor Ruth Jr stated the public hearing on June 20, and everyone will have the opportunity to speak either for or against this moratorium. Commissioner Todd stated it is not just unique to Stage Run but all over town. Lois Schretenthalen, Stage Run Resident, questioned what happens to the short-term rentals that are active now. Attorney Riggins stated with the passage of the moratorium, current legal short-term rental would not be affected. Nancy Clausen, Stage Run Resident, questioned if the tenants are allowed to rent when not living there and concerned about safety issue with everyone coming and going. Commissioner Martinisko stated if there are any issues concerning safety, please contact the Police Department. Roll Call: Aye-All. Motion carried.

Sandy Glover, Fire Department, stated there will be an open house on Wednesday, June 29 to commemorate the 20th Anniversary of the Grizzly Gulch Fire.

Attorney Riggins requested Executive Session for legal matters per SDCL 1-25-2(3) and personnel matters per SDCL 1-25(1) with possible action.

Martinisko moved, Struble seconded to adjourn the regular session at 5:58 p.m. and convene into Executive Session for legal matters per SDCL 1-25-2(3) with possible action. The next regular meeting will be on Monday, June 6, 2022 at 5:00 p.m.

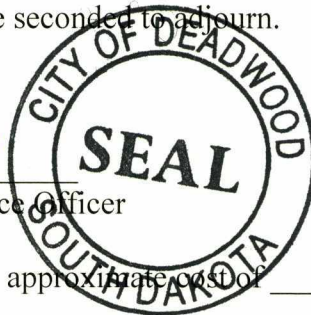
