WHEREAS, FORGEY has agreed to enter into a contract with the CITY to remove 75 feet of curb and 1 concrete street panel on Dakota Street. The total amount for completion of the work shall be Seven Thousand One Hundred Thirty Dollars (\$7,130.00); and

WHEREAS, the purpose of this agreement is to set forth the terms and conditions for which FORGEY shall provide the construction services described above; and

WHEREAS, the CITY has accepted the proposal from FORGEY, the parties agree as follows:

- 1. The Recitals set forth above are herein incorporated and made part of this Agreement;
- 2. FORGEY shall remove and replace 75 feet of curb and 1 concrete panel on Dakota Street;
- 3. FORGEY shall provide all signage and/or other markers/barriers to prevent injuries to persons or property near the work area;
- 4. FORGEY will maintain the sidewalk for the public to enter and exit safely while construction is proceeding;
- 5. All work shall be done in a professional and workmanlike manner;
- 6. All work will be subject to a final inspection by the Deadwood Public Works Department before acceptance;

- 7. No further changes or additional work will be approved by the CITY, unless approved in writing by both parties;
- 8. FORGEY shall comply with all local and state laws relating to workmen's compensation and additional insurance requirements to adequately protect the CITY from any claims or damages arising out of or in conjunction with the work contemplated herein;
- 9. FORGEY agrees to indemnify and hold harmless CITY and any of its officers, agents, and employees from any and all liabilities, actions, causes of actions, claims or executions of any character, including attorney's fees, or any sums which CITY may have to pay to any person on account of any personal or bodily injury, death or property damage, which results from any negligent act, error or omission of FORGEY in connection with this agreement or services performed or materials provided pursuant to this contract;
- 10. CITY may, at its option, terminate this agreement for any reason upon thirty (30) days notice to FORGEY;
- 11. CITY shall pay FORGEY a sum not to exceed Five Thousand Five Hundred Dollars (\$7,130.00), upon completion of work; and
- 12. FORGEY shall perform these services with reasonable diligence and expediency consistent with sound professional practices.

SUMMARY

Change Order #6 for the Lower Main Welcome Center Project is a compilation of items including several that were added at the request of the City. Additionally, structural changes that were required for some additional roof support and some painting required for esthetic purposes are included. Below is a brief summary regarding these items and attached is a copy of the Change Order:

- Sidewalk sealant & seating wall cap joint sealant this part of the CO is a credit for the sealant used; the specified product was no longer available and the replacement product, was cheaper.
- The exposed bolt heads, nuts and washers for the heavy timber framing did not match the hardware color. It was determined that we should paint them to match the hardware.
- City requested items include:
 - o Provide an access door and roof hydrant above the large meeting room.
 - Provide an additional office for future use this was approved at a previous meeting; the estimate at that time, from our consultant, was \$16,600.00 the actual cost is \$2,850.00 higher.
 - The original design included landscaping between the new seating walls and the highway, the City has requested pavement in this area
- Some structural framing changes/clarifications that required some additional material/ labor were made.

RECCOMMENDATION

It is my recommendation that the Commission approve the Change Order #6 for Ainsworth Benning Inc. in the amount of \$27,155.00
