#### TROLLEY CLEANING CONTRACT

This Agreement, made and entered into on this 1st day of July, 2015, is between Black Hills Special Services Cooperative (BHSSC) and the City of Deadwood. The purpose of this Agreement is to set forth the terms and conditions under which BHSSC will provide trolley cleaning services. It is agreed that the City of Deadwood will compensate at a rate of \$30.00 per trolley, and \$16.00 per car, SUV, or pickup, to be billed separate, for services as outlined below.

The following duties will start no later than 8:00 a.m. daily from Memorial Day weekend of each year to Columbus Day weekend of each year. From Columbus Day weekend of each year to Memorial Day weekend of each year, duties will start no later than 8:00 a.m. on Friday, Saturday, Sunday, and Tuesday of every week. The schedule may be subject to change at direction of trolley manager with 24 hours notice.

- Sweep, vacuum, mop, wash, dust and polish inside of each trolley, car, SUV or pickup.
- Wash wheels and wheel covers
- Wash outside of each trolley, car, SUV or pickup
- Wash windows
- Fill each trolley with gas

In addition, twice a year (in the spring and fall of each year), the following duties will be completed:

- Wax six trolleys
- Shampoo upholstery for six trolleys

Work will be performed as an independent contractor and not as an agent, employee or partner of the City of Deadwood. Also, contractors hired by cleaner to perform any of the work described about shall also be independent contractors and shall comply with all of the terms and conditions of this agreement, which compliance shall be the responsibility of cleaner.

The cleaner shall not commence work until they have obtained all the insurance required and insurance has been approved by the Owner, nor shall the cleaner allow any Subcontractors to commence work on this contract until the insurance required of the Subcontractor has been obtained and approved. Certification of Insurance shall be submitted to the City Finance Office.

Worker's Compensation Insurance: The Contractor shall procure and maintain during the life of this contract, Workman's Compensation Insurance as required by applicable state laws for all its employees to be engaged in work at the site of the project under this contract, and in case of any work done by subcontractors similarly to provide Workman's Compensation Insurance for all employees to be engaged in work unless such employees are covered by the protections afforded by the Contractor's Workman's Compensation Insurance.

Contractor's Public Liability and Property Damage Insurance: The contractor shall procure and shall maintain during the life of this contact, Contractor's Public Liability Insurance in an amount of not less than \$1,000,000 for injuries, including accidental death, to any one person, and subject to the same for each person, in an amount of not less than \$1,000,000 on an account of one accident, and Contractor's Property Damage Insurance in an amount of not less than \$1,000,000 and subject to the same limit for aggregate, in an amount of not less than \$1,000,000.

The cleaner agrees to indemnify and save harmless the City of Deadwood and any and all of its officers, agents and employees from any and all liabilities, actions, claims or executions of any character including attorney fees, or any sums which the City may have to pay to any person on account of any personal or bodily injury, death or property damage which results from any negligent act, error or omission of the cleaner in connection with this agreement or services performed or materials provided pursuant to this agreement.

The City may suspend or terminate any or all services covered under this agreement at any time upon thirty days written notice to cleaner upon payment of all services rendered and expenses prior to the effective date of such suspension or termination, and may immediately suspend or terminate this agreement upon a violation or breach of any of the terms and conditions by the cleaner.

On May 13, 2015, the Deadwood Historic Preservation Commission recommended approval of the Broken Boot application for the 2015 Not-for-Profit Grant program.

The Broken Boot Mine requested funding to help offset costs to repair failing timbers and rotting wood; upgrade exterior signs; complete the upgrading of the interior lighting; paint exterior; and replace the older section of the gold panning cover.

In May 2013 the Broken Boot Mine was granted \$8,400.00 to help support efforts to install an industrial fan; install an additional wall/door to allow for proper air-flow; repair and replace mine timbers; and rebuild the outdoor gold-panning area.

#### STATE OF SOUTH DAKOTA AGREEMENT FOR LAND AND WATER CONSERVATION FUND ASSISTANCE

Project Scope: The City of Deadwood will remove existing playground equipment, purchase and install replacement playground equipment with safety surfacing at Gordon Park.

The State does not pledge the assets of the State of South Dakota, nor does it promise to pay any part of the contract sum to the Participant from any monies of the State of South Dakota.

- B. The Participant pledges to accomplish the project scope, to submit all reports required and to maintain the finished project for public use, and outdoor recreation enjoyment. The Participant further agrees to reimburse the State for all losses suffered due to the failure of the Participant to meet the obligations as set forth in this agreement.
- C. The parties agree to the following:
  - This agreement may be rescinded, modified, or amended only through written approval of both parties. The Participant shall submit to the State written requests, and acquire its written approval prior to implementing any modifications in the "Project Scope, Project Period, or Cost".
  - The Participant may request reimbursement of eligible costs incurred for development and/or acquisition pursuant to the "Project Scope" by submitting to the State a billing report substantiated by carbon or photostatic copies of invoices issued to, and canceled warrants or checks issued by, the Participant in payment of such eligible costs.
  - 3. The Participant shall maintain, according to generally accepted accounting procedures, satisfactory financial accounts, documents, records of service, material, equipment, labor and real property pertinent to the project and shall retain such records and documents for five (5) years following project completion.

- 4. The Participant shall comply with the Federal Single Audit Act Amendments of 1996, Public Law 104-156, and OMB Circular A-133, "Audits of States, Local Governments, and Non-Profit Organizations", in effect for the period covered by
  - this contract. The Single Audit Act Amendments and OMB Circular A-133 require that recipients/sub-recipients of federal awards, whose expenditures of federal awards in the recipient/sub recipient's fiscal year are \$500,000.00 or more, shall have an audit made for that fiscal year. Additionally, Participants shall comply with the audit requirements of SDCL 4-11, as applicable. Audits should be coordinated with the South Dakota Department of Legislative Audit.
- 5. Site plans, location maps, structure plans and any other plans and/or specifications shall be submitted to the State for approval, and upon approval become a part of the terms of this agreement.
- 6. All new electric wires under 15 KV and telephone wires located within the project boundaries, shall be placed underground. In no case shall mass recreation use areas (swimming, picnicking, etc.) be located under electrical wires.
- 7. The Participant shall comply with Executive Order 12432, Minority Business Development. It is national policy to place a fair share of purchases with minority business firms. In particular, recipients should:
  - A. Place minority business firms on bidder's mailing lists.
  - B. Solicit these firms whenever they are potential sources of supplies, equipment, construction or services.
  - C. Where feasible, divide total requirements into smaller needs and set delivery schedules that will encourage participation by these firms.
  - D. Use the assistance of the minority business development agency of the Department of Commerce, the Small Business Administration, the Office of Small Disadvantaged Business Utilization, Department of the Interior, The Business Utilization and Development Specialists who reside in each Department of the Interior Bureau Office and similar State and local offices, where they exist.
- 8. The participant must comply with the overtime and minimum wage requirements of the Fair Labor Standards Act. This Act provides that any local government employees whose salaries are a part of the costs reimbursed with federal funds, must be paid no less than the federal minimum wage of \$7.25/hour, one and one-half their regular pay rates after 40 hours of work in a week and certain limitations on the type of work that an employee less than 18 years of age can be allowed to do. - 11. The Participant shall complete the project work in compliance with all applicable state and local laws and regulations, and in compliance with "project scope" and approved plans and specifications.
- 12. The Participant shall permit periodic site visits by the State to insure work progress is in accordance with the approved plans, specifications, and "Project Scope" including a final inspection upon project completion, as well as subsequent periodic inspections to insure adequate maintenance and proper operation.
- 13. The Participant agrees that if any real property acquired or developed under this agreement is converted to other than public outdoor recreational use, the Participant shall substitute for the converted real property other recreational properties of at least equal fair market value and of reasonable size and equivalent usefulness. Replacement property shall be subject to approval by the State.
- 14. The Participant shall operate and maintain facilities developed pursuant to this agreement for public outdoor recreation purposes for the normal life expectancy of the facilities.
- 15. The Participant shall comply with applicable Federal environmental standards, particularly the Clean Air Act and the Clean Water Act. All projects involving flood plains and wetlands shall preserve and enhance the natural and beneficial values of such land in accordance with Executive orders 11988, "Flood Plain Management" and 11990, "Protection of Wetlands".
- 16. The Participant shall not discriminate against anyone on the basis of residence, except to the extent of reasonable differences in admission or other fees.
- 17. The Participant shall comply with the provision of Title VI of the Civil Rights Act of In short, as a recipient of Land and Water Conservation Fund assistance the participant must assure that their recreational facilities and programs are open to all persons, regardless of race, color, national origin, age or handicap.
- 18. The Participant shall comply with the provision of the Department of Justice 28 CFR Part 35. This regulation provides that no qualified handicapped person shall, on the basis of handicap, be excluded from participation in, be denied the benefits of, be subjected to discrimination, or be denied access to any assisted facility or site under any program or activity receiving Federal financial assistance. In this regard all facilities designed, constructed or altered with LWCF assistance, must be accomplished in accordance with the specifications contained in 28 CFR Part 35.
- 19. The Catalog of Federal Domestic Assistance number (CFDA #) for the Land & Water Conservation Fund is <u>15.916</u>, titled Outdoor Recreation, Acquisition, Development, & Planning.
- 20. The Participant shall comply with the applicable federal uniform administrative rules for domestic assistance programs of the US Department of the Interior, found in 2 CFR

21. The general public must be made aware of the Participant's nondiscrimination policy and the right to file complaints alleging violations of Title VI and Section 504. This must be done annually on a continuing basis and can be accomplished through newspaper notices and/or posters. In addition all major brochures, recreation schedules, or advertisements must contain this information. Suggested language is:

"Equal opportunity to participate in and benefit from recreational facilities or programs is available to all persons regardless of race, color, national origin, age or handicap. Complaints alleging discrimination should be sent to the South Dakota Department of Game, Fish and Parks, 523 E. Capitol Avenue, Pierre, South Dakota 57501 or the Office For Equal Opportunity, U.S. Department of the Interior, Office of Secretary, Washington, DC 20240."

- 22. The Participant shall comply with all policies and procedures set forth in the National Park Service Land and Water Conservation Fund Grants Manual. Said manual is hereby incorporated into and made a part of this agreement.
- 23. Failure by the Participant to comply with the terms of the agreement shall be cause for suspension of all obligations of the State hereunder.

#### **SUMMARY**

We have budgeted money for a project to make some improvements to part of the Sherman St. parking lot across from the old Pizza Hut building. This project also included changing the location of the approach from Charles St. The DOT agreed to make that change in the Highway 85 reconstruction project. The curb and gutter work for the original design included tie-ins to existing curb work that was part of the deadwood monument sign in this area. With the change in the location of the approach and plans for parking lot improvements, this curb work is not practical and would have to be removed when the parking lot improvements occur. The DOT has agreed to make changes to this curb that will benefit our future parking lot plans. To do this a change order for the DOT project will be required. The DOT is requesting a letter from the City that indicates the City will re-imburse the DOT for this additional work (estimated at \$8,840.20). The money for this re-imbursement should be paid for from the budgeted project.

Declare Emergency for Retaining Wall located at 10 Harrison

The property owner of 10 Harrison, Travis Conrad, applied and has been accepted into the Historic Preservation Commission's Retaining Wall program. Preliminary engineering has been completed and this office was in consultation with the owner and adjacent property owner in review of the plans; however, on Monday, May 11, 2015 the wall failed and fell against the house creating an unsafe condition which if not immediately addressed could be otherwise dangerous to human life and welfare. A previously scheduled meeting with the property owner and engineer had been set for Thursday, May 14, 2015; meanwhile the wall continued to fail adding additional pressure to the wall of the house.

This office, in consultation with the City Building Official and Public Works Director, met on Thursday, May 14, 2015 on site with following individuals: Mike Albertson, Albertson Engineering; Travis Conrad, property owner; Tim Conrad; Mike Gilberts, adjacent property owner; Mark Speirs, City Commissioner; and Thad Fuller, CAI2 Construction. The engineer determined the wall failure did indeed create an unsafe condition and provided a construction directive to remove the pressure of the failed wall from the house (see attached correspondence).

Under SDCL 5-18A-9; an emergency procurement shall be made with such competition as is practicable under the circumstances. Due to the unsafe conditions and the predicted moisture over the next week, it was determined to proceed with the engineering directive and the mutually agreed upon contractor to remove the unsafe conditions in a timely manner. Contractor will be responsible the removal of the Conrad shed and tree, removal of the Gilbert sauna, fence and deck, and the removal of soils and concrete against the house for an amount not to exceed \$22,000.00.

The written determination of the basis for the emergency along with the selection of the particular contractor will be included in the contract file for necessary documentation of this declaration of an emergency procurement.

**Recommended Action:** Declare the Retaining Wall failure located at 10 Harrison an emergency and authorize the procurement of services not to exceed \$22,000.00 with CAI2 Construction to make the property safe.

Collapsed existing retaining wall

On May 14, 2015 I observed the existing conditions of the retaining wall along the east and south side of the residence at 10 Harrison. The observation was in response to your request based upon a collapse stated to have occurred on May 12, 2015. At the time of our observation several items of note were observed, including:

- Concrete retaining wall extending along east side of residence has failed from the south corner of the wall to an
  area close to a large tree approximately 25' north of the south end of wall. The collapsed wall is pressing up
  against the exterior wall of the residence. The short stone wall that formerly was behind and above the concrete
  wall has also failed as a result of larger lower wall failure. The remnants of that wall and of the backfill have
  combined with the larger retaining wall and are in turn also pressing against exterior wall of residence.
- The failed retaining walls and backfill are reported to be continuing to move westward towards house
- Concrete wall along south side of residence has failed from east corner for a distance of approximately 20'. At this time the wall is not pressing up against the residence but does not appear to be a stable position.
- For reference purposes the property to the west of the retaining along east side residence is Travis Conrad and the property to the east of said wall is Mike Guilbert.
- Several parties were at site including:

- Significant discussions occurred regarding design and construction of replacement retaining walls and area to
  south of proposed south wall extending to street, drainage pan along east side of Conrad residence, sensitivity of
  items along west side of Guilbert residence. A solid direction on the design of the new walls was made and will
  be shown in future designs to be completed shortly. Many technically difficult issues exist in regards to both the
  design and the construction of the walls.

The exterior wall of the residence is intended to resist the loads imparted upon it by the failed retaining wall and in our opinion represents an unsafe condition which needs immediate action to correct and hopefully prevent any failure of the structure for the house. Time is of the essence and corrective actions need to be completed as soon as possible. In our opinion this clearly represents an emergency situation. It is our recommendation that:

- Retaining wall near east wall of residence from the large tree near sauna on adjacent property to the south end of wall be removed and disposed. Stone to be salvaged to the degree reasonable
- Retaining wall along south side of residence from east end of south wall to the first corner west of the SE corner (approximately 20') be removed and disposed.
- Soil be removed from base of wall to existing grades at a slope no steeper than 1.5 to 1.
- Shed at Conrad property to be removed and disposed

- Sauna at Guilbert residence needs to be relocated
- Decks to south of Sauna at Guilbert residence needs to be relocated
- Construction fencing be placed around excavated area
- Power to Guilbert sauna and Conrad shed be disconnected (Travis Conrad was going to complete yet that day)
- Topographic survey be completed of majority of Conrad lot, adjacent areas of neighbor to east and Guilbert
  residence, and street to south of residence to allow for design of replacement retaining walls. AE2S was in
  Deadwood at the time of the observations and was brought to site shortly following meeting to discuss survey
  requirements. AE2S is adjusting their schedules to allow for starting on the topographic survey on the following
  day (May 15, 2015) due to urgency of project.
- Occupancy of the southern portion of the Conrad residence be extremely limited in nature and made with understanding that a serious and significant risk exists while in those areas until such time as the remedial measures stated above are completed.

g. Portions of a single construction project may be awarded to several different bidders, however, the value of the total project must be considered when comparing to the bid limit to determine if it must be bid.

Further, when comparing to the bid limit to determine if a project is biddable, the total project value may be reduced for any portion of the project that is exempt from bidding, such as items acquired from federal surplus property or for costs incurred by an entity's own employees and equipment. But the total project value may not be reduced by any portion of the project that was previously bid by yourself or other entities.

#### Quote vs. Bid

The bid process is a formalized open and competitive procedure utilizing two notices in the legal newspaper to secure proposals. Quotes, on the other hand, are an informal process utilizing phone contact, faxes or other methods to secure proposals. Quotes are used in special purchasing situations such as emergencies or the purchase of fuel and for purchases that are under the bid limit.

#### **Emergency Purchases**

A purchasing agency may make or authorize others to make an emergency procurement without advertising the procurement if rentals are not practicable and there exists a threat to public health, welfare, or safety or for other urgent and compelling reasons. Failure to abide by the bid provisions of this chapter and chapters 5-18B, 5-18C, and 5-18D in a timely manner is not an emergency. An emergency procurement shall be made with such competition as is practicable under the circumstances. A written determination of the basis for the emergency and for the selection of the particular contractor shall be included in the contract file. (SDCL 5-18A-9)

#### **Exemptions from Bidding**

The following type contracts are exempt from bidding:

- a. Purchase of utility services such as electric power, lights, water or gas. (SDCL 5-18A-22 (5)).
- b. Any contract for the purchase of supplies from the United States or its agencies or any contract issued by the General Services Administration. (SDCL 5-18A-22 (2))
- c. Equipment repair contracts. (SDCL 5-18A-22 (4))
- d. Purchases of surplus property from another South Dakota purchasing agency. (SDCL 5-18A-22 (10))
- e. Purchases by a local government from the lowest bidder of an item contained on the state price list. The state bid price list may be obtained on the internet at <a href="www.state.sd.us/boa/">www.state.sd.us/boa/</a>. Double click on "Procurement Management" and then click on "Contracts" to secure of list of state contracts. (SDCL 5-18C-8)
