# **History Repeats Itself?**

Does history repeat itself? It depends on what is written and retained in way of records. October 1918 was to become the deadliest month in American history resulting from the influenza epidemic, known as the Spanish Influenza, that ravaged the country.

In Deadwood, the City Board of Health published a series of notices in the local newspapers prohibiting public gatherings to help

stop the spread of the flu. Under this pretense, Deadwood's public schools followed suit and closed its doors on October 14, 1918 as written in notes at the bottom of the Secretary's & Warrant Ledger for Independent School District #02, on file in the City Archives. Three months would transpire before Deadwood's public schools reopened on January 13, 1919.

For many of us, the Covid-19 pandemic is impacting our government, work, family, and lives in a multitude of levels similar to what happened 102 years ago. The silver lining, if there is one, is we can draw from past experiences to prepare for the new future that awaits us. On behalf of the City of Deadwood, be healthy and safe during these challenging times.


"These people and organizations represent the best of our state," said Governor Kristi Noem. "Through their efforts, South Dakota history will be preserved for future generations."

# TRI-CITY SPRING CLEAN UP

LEAD • DEADWOOD • CENTRAL CITY • LAWRENCE COUNTY

#### Monday, May 11 through Saturday, May 16

City crews will NOT be assisting with cleanup at this time

The Tri City Rubble Site will be open for FREE dumping each of these days from 8:00 AM to 4:00 PM.

Deadwood, Lead, Central City and Lawrence County residents may use the Rubble Site free of charge for those 6 days. Residential loads only for free dump usage.

ALL COMMERCIAL VEHICLES AND TRAILER LOADS MAY STILL DUMP AT THE USUAL RATE.

# ABSOLUTELY NO RAW HOUSEHOLD GARBAGE, PAPER, CARDBOARD, PLASTIC, CLOTHING, ASBESTOS, CHEMICALS OR HAZARDOUS/TOXIC/OR MEDICAL WASTE WILL BE ALLOWED.

Items that are acceptable include: trees, wood, brush, yard waste, concrete, asphalt, asphalt shingles, rock, clean soil, iron, steel, metals, batteries, tires, sheetrock, vehicles, white goods and furniture.

All loads taken to the Rubble Site must be sorted. All waste must be placed in its designated places

- Loads must be sorted as follows: 1. Wood, trees, brush, burnable construction debris (not containing plastic, sheetrock, asphalt shingles, insulation or any metals)
- Metals (iron, steel, aluminum, white goods, appliances, etc.)
- 3. Asphalt, concrete, rock, gravel 4. Furniture, mattresses, sheetrock, asphalt shingles, styro-foam, fiberglass insulation, tar paper
- 5. Yard waste, grass clippings, leaves, vines, wood chips, etc.
- 6. Clean dirt, top soil
- 7. Vehicles FREE with title

If the load is mixed and the individual hauling the load will not sort it, the load will NOT be allowed in the dump. <u>TIRES ON RIMS WILL NOT BE ACCEPTED!</u> NO EXCEPTIONS.

There are a few items for which residents will have to pay a fee to dump. They are as follows: Appliances which are not tagged by a licensed Freon remover \$40 Old tube-style (CRT) televisions \$10

- Car tires up to 15 inches \$3
- Truck tires up to 16 inches \$5 Truck tires up to 20 inches \$25 Tractor or loader tires \$25

Due to the Covid-19 pandemic, city crews will be unable to help with this spring cleanup. As the summer progresses, the cities will review the situation and, if possible, help with a Free Dump Weekend in September. There is already a Free Dump Weekend scheduled for September 3-4-5 and this may be extended into earlier that week. The cities and county hope everyone understands the concerns that exist today. #### Moratorium on Historic Preservation Grants and Forgivable Loans

The City of Deadwood Historic Preservation Commission has placed a moratorium on new applications for the Historic Preservation Grant and Forgivable Loan Programs effective April 30, 2020 until further notice. The Covid-19 pandemic and associated measures have put a tremendous burden on the City and Historic Preservation budgets.

The Historic Preservation Commission will monitor the overall impact of the pandemic's economic and budgetary implications on a regular basis to reassess the moratorium's status and make a determination of when and if the programs can be revived. ### Water Department

Many products these days are marketed as flushable. From disposable toilet bowl cleaners to wipes that clean your "bum". The City of Deadwood Water Department wants you to know these items cannot be flushed. Some of these items claim they dissolve enough to make it down your toilet but they re-form once they enter the sewer and may cause sewer back up which can damage pumping equipment.

The following is a list of some of the items which do not dissolve in the sewer and can cause sewer backups in your home or neighborhood.

#### DO NOT FLUSH LIST:

diapers

hair

- facial tissue
- cotton swabs baby wipes body wipes
- chewing gum candy wrappers
  - facial pads/wipes
- dental floss/picks
  cigarettes kitty litter
- cotton balls cleaning wipes
- toilet wand pads • condoms

• paper towels

 bandages contact lenses

• pet fish

- cooking grease/oil
- pills/medications
- · feminine hygiene products

Please remember, your toilet is NOT a trash can!

#### Yard Waste Dumpster

The yard waste dumpster is now available at Public Works for grass clippings and yard waste. Yard waste consists of grass clippings, leaves, twigs, and hedge trimmings. Branches and household garbage is not allowed in the dumpster.

Branches and larger pieces of wood need to be dropped off in the designated area. Look for signs to direct you to the proper drop off location.

# **Deadwood Historic Preservation** Loan Deferment Policy

Purpose: The purpose of this policy is to outline a deferred payment plan to assist borrowers in meeting their financial obligations to Deadwood Historic Preservation.

Scope: This policy applies to all eligible Deadwood Historic Preservation borrowers, that have been negatively impacted by the COVID-19 virus.

Policy: If full payment is not possible, the borrower(s) may be placed in a deferred payment plan. The borrower must submit a written request to apply for a deferred payment plan no later than 6/30/2020. The borrower may be required to submit proof of a loss in income caused by the COVID-19 virus. The Deferral of payment request will be reviewed by the DHP Loan Committee and DHP Commission for approval. The borrower may be granted a 30, 60 or 90-day deferral based on the borrower's circumstances. Additional deferral options beyond 90 days will be reviewed and implemented accordingly by the DHP Commission based on situational changes in the COVID-19 outbreak. Interest will continue to accrue on loans regardless of the deferred payment plan. The borrower(s) acknowledge that by utilizing this program, the deferred payments will be added to the end of the loan and result in an extension of the loans maturity date, based on the amount of principal and interest that has been deferred. In order to utilize this program, the requesting borrower(s) must work with NeighborWorks staff to complete and sign all appropriate loan documents prior to the plan going into effect.

#### Additional temporary changes to the Deadwood Historic Preservation loan policy:

- Borrowers Late payments will not be reported to the credit bureau during the time that the deferred payment plan is in effect or through June 30<sup>th</sup>, 2020 whichever is later.
- Late fees will not be charged to the borrower during the deferred payment period or through June  $30^{\text{th}}$ , 2020 whichever is later and any fees that may have been charged by mistake will be waived.
- Foreclosures will be suspended during the deferred payment period, or through June 30<sup>th,</sup> 2020 whichever is later.
- These temporary changes shall expire no later than 7/31/2020 unless extended by the Deadwood Historic Preservation Commission and all applications for a deferred payment plan must be submitted in writing no later than 6/30/2020.

These changes to the loan policy are temporary and apply to borrowers negatively impacted by the COVID- 19 virus only. All other loan terms and conditions still apply.

- By state, Utah had the highest cumulative total self-response rate (46.1 percent) on Census Day for all Western states, followed by Washington (45.0 percent) and Idaho (44.2 percent)
- Daily Top Western Counties by area on Census Day: Jefferson County, Colorado (5.5 percent)
- Cumulative Top Counties on Census Day by area of the country: Los Alamos County, New Mexico (56.9 percent)
- Colorado had the highest daily total self-response rate on Census Day (3.8 percent) for all Western states, followed by Utah (3.2 percent) and California (3.1 percent)
- Kentucky and Texas tied for the highest total self-response rate at 0.8 percent on April 6
- Wichita County, Kansas and Carson County, Texas tied for the highest daily internet self-response rate on April 6

# Deadwood Firewise Program

In the fire prevention world, May 2 is recognized as "Wildfire Community Preparedness Day". The National Fire Protection Association (NFPA) has published an online toolkit that homeowners and the general public can use to protect their homes against the threat of wildfire. Simple home projects outlined on the NFPA website include:

- Raking and removing pine needles and dry leaves within a minimum of 3 to 5 feet of a home's foundation. And if you have the time, continue raking up to a 30-foot distance around the home. Dispose of collected debris in appropriate trash receptacles.
- Cleaning pine needles from your roof and gutters and paying attention to maintaining the home ignition zone.
- Getting out your measuring tape and seeing how close wood piles are located to the home. If they are closer than 30 feet, relocate them to at least 30 feet away from structures.
- Sweeping porches and decks, clearing them of leaves and pine needles. Raking under decks, porches, sheds, and play structures.
- Mowing grasses to a height of 4 inches or less.
- Removing items stored under decks and porches and relocating them to a storage shed, garage, or basement. Gasoline cans and portable propane tanks should never be stored indoors and should be located away from the home.
