**DEADWOOD HISTORIC PRESERVATION COMMISSION  
INITIATES NEW GRANT FOR RESIDENTIAL REHABILITATION**

The City of Deadwood Historic Preservation Commission is introducing a program to residents in the City of Deadwood to help stimulate the quality restoration and protection of structures contributing to the historic integrity of the City of Deadwood. The recipient of the program will receive grant funds for the restoration or rehabilitation of the historic exterior, roof, siding, foundation, windows and life safety issues to include plumbing, electrical, HVAC, retaining wall and drainage. All costs associated with the restoring or repairing of exterior and life safety issues will be paid 100% by the Historic Preservation Commission with a cap of \$100,000.

The recipient must first be nominated for the program by a neighbor or resident. The application will be reviewed by the Neighborhood Block Club Council and recommendations will be made to a selection committee for final nomination to the Historic Preservation Commission for approval or denial.

To be eligible, the structure must be located on a primary street, easily viewable from the right-of-way and listed as a contributing historic property. The structure must be a residential property and the owner occupied for at least ten years. A non-contributing building may be eligible if the removal of inappropriate alterations or the reconstruction of missing details will reverse the listing to a contributing resource.

### ADDRESS IDENTIFICATION REMINDER

The Deadwood Police Department would like to remind business and home owners of the following City of Deadwood Ordinances:

#### Chapter 12.04.050 Premises identification.

It shall be the duty of every person owning or occupying any new or existing house, or other building constructed in the city fronting any public or private street, to place and maintain premise identification in accordance with section 12.04.060.

#### Chapter 12.04.0607.f. Address location and size.

7. f. If the owner or lessee of any building shall fail, refuse, or neglect to place the number, or replace it when necessary, the building inspector or the Deadwood Police Department may cause a notice to be personally served on such owner or lessee or mailed by registered mail to his/her last known address, ordering him/her to place or replace the number. Such owner or lessee shall comply with this notice within ten (10) days from the date of service.

### April Is Distracted Driving Awareness Month

The National Safety Council (NSC) has an urgent request for all drivers: Make April the month you ditch the cell phone – and distracted driving – while behind the wheel.

"It's time to start changing the social acceptance of cell phone use while driving," said Janet Froetscher, NSC president and CEO. The resolution mentions 9-year-old Erica Forney, who was struck and killed by a distracted driver in Fort Collins, Colo., in November 2008.

Thousands of fatal crashes each year involve drivers using cell phones. NSC encourages everyone to take the pledge to drive cell-free during April and beyond. Employers can celebrate Distracted Driving Awareness Month by implementing total bans on cell phone use while driving for all employees. ## **City of Deadwood – 2015 Drinking Water Report**

**Water Quality:** Last year, the city of Deadwood monitored your drinking water for possible contaminants. The following is a snapshot of the quality of the water and we provided last year. Included are details about where your water comes from, what it contains and how it compares to Environmental Protection Agency (EPA) and state standards. We are committed to providing you with information because informed customers are our best allies.

**Water Source:** We serve more than 1,270 customers an average of 382,000 gallons of water per day. Our water is surface water we purchase from another water system; the City of Deadwood public water system purchases 100% of their water from Lead-Deadwood Sanitary District (0190). The state performed an assessment of our source water and they have determined that the relative susceptibility rating for the Deadwood public water supply system is medium. For more information about your water and information on opportunities to participate in public meetings, call (605) 578-2600 and ask for Mary Jo Nelson.

**Additional Information:** The sources of drinking water (both tap and bottled) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of land or through the ground, it dissolves naturally occurring minerals and picks up substances resulting from the presence of animals or from human activity. **Contaminants that may be present in source water include:**

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming;
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses;
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products and industrial processes and petroleum production, and can also, come from gas stations, urban storm water runoff, and septic systems;
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems, FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. Drinking water, including bottled, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling Environmental Protection Agency's Safe Drinking Water Hotline (800) 426-4791.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen risks of infection by Cryptosporidium and other microbial contaminants can be obtained by calling the Environment Protection Agency's Safe Drinking Water Hotline (800) 426-4791.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Deadwood's public water supply system is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at <http://www.epa.gov/safewater/lead>.

**Detected Contaminants:** To receive a copy or view a table which lists all the drinking water contaminants detected during the 2015 calendar year, contact Donovan Renner by calling (605) 578-3082.

The presence of the contaminants in the water does not necessarily indicate the water poses a health risk. Unless otherwise noted, the data presented in this table is from testing done January 1 – December 31, 2015. The state requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of the data, though representative of the water quality, is more than one year old.
